### Distances

At 46 miles long, The Withlacoochee State Trail offers a variety of distances to accommodate every level of rider. Rides can be as short or long as you want, with 4 SAG stops along the entire course. The ride will start in Inverness Trail head, with additional SAG Stops at Ridge Manor, Istachatta, and Citrus Springs. Take the Southern loop and enjoy a scenic ride into Hernando & Pasco County with fully supported SAG stops at the small town of Istachatta, including a shaded park, music, & restrooms!

48 Miles is our most popular distance and the SAG stop is located at Ridge Manor, near Hwy 50 & I-75.

100 Mile Century Challenge Complete this 50 mile stretch, end to end, and receive a commemorative Century Finisher Medallion to wear proudly.

Having read this waiver and knowing these facts and in consideration of your accepting my entry, I for myself and anyone entitled to act on my behalf, waive and release the Citrus Road Runners, USA Cycling, State of Florida, Florida Department of Environmental Protection, Chris Moling, DRC Sports, State of Florida, and all other sponsors, their representatives and successors from all claims or liabilities of any kind arising out of my participation in this event even though that liability may arise out of negligence or carelessness on the part of the person named in this waiver. I also agree that I may be examined and treated if necessary during the course of the ride by qualified personnel in the event medical problems of any cause arise. The ride officials or qualified personnel have the right to remove me from the event if, in their opinion, I may be suffering from a life threatening condition. I understand that the course is open to vehicular traffic and will compete with due care.
